OLD BUSINESS

Wellness Policy Update- Daughn Baker, Child Nutrition Director reported that Davie County Schools will be in compliance and will meet the requirements and revisions needed to make sure the Wellness Policy is being followed by the SHAC guidelines. Daughn states the compliance records will be posted on the new SHAC website. The new SHAC website is part of the DCS Website located under Departments/Student Services/SHAC.

SCHOOL HEALTH UPDATE- Kathy Bokeno, Lead School Nurse

- Kathy Bokeno, Lead School Nurse reports that she has been working on a state report called “Healthy Active Children’s Policy”. This report speaks to many of the aspects of our SHAC. The requirements of the North Carolina State Board of Education Policy regarding “Healthy Active Children” are the reason we have a SHAC committee. It makes sure we are planning, implementing and monitoring this policy as well as other health issues as part of the coordinated school plan for Davie County students. In order to complete this report we must have a set of By Laws, An Action Plan, Wellness Policies in place, and a Healthy Fitness program in all schools. Kathy states we have been doing very well meeting these requirements; however, she shared with the group that we do not have a measurement or standard in place at this time for periodic checkpoints designating which schools are/are not in compliance. This is area we will work on getting in place this year and post on the SHAC website. Kathy thanked all those present for their contribution and dedications to the SHAC committee and the children of Davie County.
- CPR/First Aid for School Medical Response teams and Coaches/PE teachers were taught before school started, there were around 40 trained, they were all trained in Epi Pen/Anaphylaxis administration as well. Epi Pen containers have been placed in all the schools near their AED’s with 2 Epi Pen Jr and 2 Epi Pen Adult boxes placed in each. These Epi Pens are available for staff, undiagnosed students or anyone to use that may be in one of our building and need it. These Epi Pens were Free for all locations from Epi Pens 4 Schools Program.
- Kathy Bokeno reported the Nurses have been busy working on Immunizations, Kindergarten Health Assessments and 7th grade immunizations along with checking all transfer students for complete immunization records. Only 13 students were excluded from school in the entire school district for not having up to date immunization records/KHA. They were all back in school within 2-3 days due to the hard work of our school nurses contacting parents and doctor office on the behalf of the students. Our school nurses spend a lot of time chasing and educating parents in regards to immunizations as well as other health concerns for our students. Beth Weatherman, Director of Student Services complimented the nurse staff for all the hard work in this area and for all they have done in these short 30 days to meet state requirements.
- Kathy Bokeno reported the Friendly Dental Van will be coming around our schools again this year. It has been a great success and now serves all the Elementary, Middle and High School. This program will work in conjunction with our state Dental Hygienist program. The Friendly Dental Van usually helps children on Medicaid, but can also help children without insurance and they can bill the insurance company for those with insurance as well. They try to encourage all students to find a primary dentist. Dr. Clio Austin asked if a copy of the dental report could to go to the primary doctor as well as the parent. She addressed the importance that would be to the child Medical records. Kathy Bokeno is to look into this with the Dental Van representative and report back later.
- The Nursing staff has been giving intensive training this year for Diabetes (currently 30), Asthmatics, Allergy Reactions-Epi Pens and Medications. Teachers have been trained as well as other staff that is responsible in these areas.

DENTAL UPDATE- Becky Boulton, State Dental Hygienist, new to Davie County this year, replaced Debbye Krueger due to redistricting of State territories.

- Becky Boulton, State Dental Hygienist introduced herself to the SHAC members and shared all the programs the State wants to promote this year in the school system. This year the state wants to implement a Dental Sealant Program (probably to begin at WRD).
- Becky explained that the state would also offer a Fluoride Rinse Program; she would provide paperwork and training for this program. The program would be done by a support person in the schools. Becky indicated the program was much easier than in the past.
- Becky expressed her wish to help in our schools any way she could.

NEW BUSINESS

- Jami Lawhon, Davie County Cooperative Extension representative reported (Snap-Ed) Steps to Health for 3rd graders will be held at Cooleemee and William R. Davie Elementary Schools. This is a federal funded program; they hope to bring to more schools later on. This program starts in January 2016 and is offered through Davie County Cooperative Extension.
- The Davie Forum (Davie Community Foundation and Mebane Foundation) has not met yet this year; Kathy is a member of that board and will report to SHAC after their meeting.
- Kathy Bokeno reported the SHAC committee would need a new action plan for this year. She suggested we work on the Wellness Assessment as well as the Dental Fluoride and Sealants Programs.
- Dr. Clio Austin request getting fitness/ dental records performed at school sent to each student's doctor's office. Kathy Bokeno explained that parents were very offended when we tried this is the past. It was suggested by Andreia Collins, social worker, to have the parent sign a release at the doctor's office for the school to release information. This topic will be looked into further at a later time.
- Mike Garner reported October is the month for Youth Basketball sign ups at the Recreation Center. He asks to encourage girls to sign up as the numbers were very low this year. The Brock Gym in under renovation until November but should be ready when games start in December.
- Daughn shared they were doing fun things in Child Nutrition to make fruits and vegetables interesting. Having Contest with prizes, guessing fruit of week etc.
- Kathy Bokeno gave a presentation to the Board Members in the spring 2015 about SHAC, everything went well and she will do this again in the spring of 2016.

There being no more business, the meeting was adjourned at 1:08 pm
